Saturday 26<sup>th</sup> April 2025

Sunday 27<sup>th</sup> April 2025



The Woolbridge Motor Club Ltd will promote an **INTERCLUB** Hillclimb on Saturday 26th April 2025 and Sunday 27th April 2025 at Wiscombe Park, Devon. Motorsport UK Permit Number 201560 has been issued.

The events are open to all fully elected members of the promoting club, clubs belonging to the ASWMC, ACSMC and members of the SDMC Speed League, Classic Marques Sports Car Club, MX5 Challenge, WAMC Welsh Association, Gilbern Owners Club, Hillclimb and Sprint Association Championship and DEWS Speed Series holding the relevant Competition Licence issued by Motorsport UK. Club Membership Cards, Competition Licences and, where appropriate, Championship Registration Cards will be inspected at Signing On.

Particular attention should be paid to NCR Ch.14 App.2 Art.1.4 with reference to the need for a RS National licence for certain cars over 1100cc.

1. The Meetings will be held under the National Competition Rules of the Motorsport UK (incorporating the provisions of the International Sporting code of the FIA), these Supplementary Regulations and any written instructions the promoting club may issue for the event.
2. The length of the course is 1000 yards and consists of two sharp left-hand corners, one sharp right-hand corner and several fast bends.
3. Attention is drawn to the requirement for a Motorsport UK Logbook or Motorsport UK Recognised Vehicle Identity Document as defined by NCR Ch.14 App.1 Art.4.2  
**As you are aware, the phasing out of the old- style, Competition Car Logbooks continues with the Latest batch, CCLBs issued between 1<sup>st</sup> January 2000 and prior to 31<sup>st</sup> December 2004, having expired at the end of 2022.**  
**The date of issue on Competition Car Logbook can be found on the top right-hand corner of the Front page. However, a good suggestion from a Scrutineer was to advise you of the last CCLB. Number issued during this period, as this is an easy reference to identify the logbook.**  
**Our records show that the last CCLB issued prior to 31<sup>st</sup> December 2004 was no. 26639. So, any CCLB with this number or lower should now have expired.**
4. Provisional results will be published as soon as possible after the completion of timed runs. Appeals should be made in accordance with NCR Ch.2 App.4 Art.1.23(e)
5. Competitors will be permitted to enter Wiscombe Park (MR 193/185924) via the Course until 08:15. After that time, they will be held in the Top Paddock until it is convenient to send them down the Course.
6. Signing-on, scrutineering and practice will be conducted in Class order.
7. Competitors will be permitted to walk the course and are strongly encouraged to do so but must be clear of the hill by 08:30.
8. Cars will start singly in their own time after the green light is displayed. The method of timing will be electronic on the breaking of beams at the Start and Finish. The finish line will be indicated by a banner. Timing Struts in accordance with NCR Ch.14 App.4 Art.11 must be fitted before practice or no time will be given.
9. There will be two practice runs at each event followed by two timed runs. If time permits additional runs may be offered but these may not count towards the results
10. Competitors are responsible for providing their own competition numbers, displayed on a contrasting background, as NCR Ch.14 App.2 Art.3 Drivers of shared cars must ensure appropriate number is displayed for each run.
11. Competitors' attention is specifically drawn to the requirements of NCR Ch.14 App.2 Art.4., particularly with regard to the fitting and wearing of an FIA approved FHR device, if required, in accordance with Regulation NCR Ch.9 Art.10
12. Competitors running their car on Methanol must indicate this on the Entry Form and must also display an orange disc on their vehicle in accordance with NCR Ch.7 App.4.Art.7
13. Cars that can only be started by means of external batteries must be started in the top paddock before descending the hill. Batteries will be provided by the organisers. Crash helmets must be worn at all times when descending the hill, in accordance with NCR Ch.9 Art.5 and NCR Ch.14 App.2 Art.4
14. The use of any external device or power source to preheat the tyres of a competing car, whether the tyres are fitted to the car or not, is prohibited. This does not affect the right of a competitor to spin the wheels to induce heat into the tyres in the area designated for the purpose, but forward motion must be maintained. If, however, a driver is deemed to have deliberately stalled his engine, he may not spin his wheels until he reaches the point at which the stall occurred.
15. Competitors are informed that some information from the Entry Form for these events will be stored in a computer system by the Event/Entries Secretaries for the use of Woolbridge Motor Club Ltd in the administration of Speed events. May we also draw your attention to that some of the Wiscombe Park events may be "livestreamed" to social media (Facebook and YouTube). By entering these events you consent to yourself and your vehicle being broad cast as part of the live footage of the event and in any subsequent re – transmissions.

16. Competitors are reminded that their time will be credited only if all four wheels of the car are on the track when it crosses the finish line, in accordance with NCR Ch.14 App.3 Art.3.3

Furthermore, if a competitor is observed to have all 4 wheels off the track, at any point on the hill, their time will not be credited.

17. **The programme of the Meeting will be as follows:**

- Signing-on will start at approximately 0730 in the Bottom Paddock
- Scrutineering will start at approximately 0745 and will be conducted in your paddock space.
- Practice will start at approximately 0830
- The first competitive run will be at approximately 1345

18. Any competitor who, because of distance or other genuine reason, finds difficulty in complying with the times above may report at a different time provided that prior permission has been obtained from the Clerk of the Course.

19. **Classes will be as follows: -**

**Class A0.** Junior Driver Class competing in Standard Cars maximum power output 110bhp.

**Class A1.** Road Cars Series Production up to 1400cc.

**Class A2.** Road Cars Series Production over 1400cc and up to 1800cc.

**Class A3.** Road Cars Series Production over 1800cc and up to 2600cc.

**Class A4.** Road Cars Series Production over 2600cc.

**Class B1.** Road Cars Specialist Production. Car engines up to 1400cc.

**Class B2.** Road Cars Specialist Production. Car engines over 1400cc up to 1800cc.

**Class B3.** Road Cars Specialist Production. Car engines over 1800cc and all Motorcycle Engines.

**Class C1.** Modified Cars Series Production up to 1400cc.

**Class C2.** Modified Cars Series Production over 1400cc up to 1800cc.

**Class C3.** Modified Cars Series Production over 1800cc.

**Class C4.** Modified Cars Specialist Production Car engines & Motorcycle engines.

**Class D1.** Sports Libre Cars up to 1800cc.

**Class D2.** Sports Libre Cars over 1800cc.

**Class D3.** Rally Cars.

**Class E1.** Racing cars up to 1100cc.

**Class E2.** Racing cars over 1100cc and up to 1600cc.

**Class E3.** Racing cars over 1600cc and up to 2000cc.

**Class E4.** Racing cars over 2000cc

**Class F.** Cars of the DEWS Motor Club

**Class G** Cars of the Gilbern Owners Club

**Class H.** MX5 Challenge

**Class I.** Classic Marques

**Class J.** Cars of the MSCC Championship (**Sunday only**)

**Note 1:**

All cars must comply with NCR Ch.14 App.4 Art.2.1-2.5

**Note 2:**

Junior Class Drivers and cars must comply with NCR Ch.14 App.2 Art.1.9 and NCR Ch.14 App.2 Art.1.11

**Note 3:**

- Road Cars Series Production are defined as cars complying with NCR Ch.14 App.4 Art.17-23
- Road Cars Specialist Production are defined as cars complying with NCR Ch.14 App.4 Art.17-22
- Modified Cars Series Production are defined as cars complying with NCR Ch.14 App.4 Art.24-30. Must have been available to the general public and originally designed for use on the public highway in road legal form. It must have been manufactured in the required production numbers 1000 per year.
- Modified Cars Specialist Production are defined as cars complying with NCR Ch.14 App.4 Art.24.3, and NCR Ch.14 App.4 Art.24.5-30. Must have been available to the general public and originally designed for use on the public highway in road legal form. It must have been manufactured in the required production numbers 20 per year.
- Sports Libre Cars must comply with NCR Ch.14 App.4 Art.31
- Racing cars with NCR Ch.14 App.4 Art.32
- Rally Cars must comply with NCR Ch.13 App.16, NCR Ch.13 App.17 and NCR Ch.14 App.4 Art.31. Included in the latter Category would be Group B cars, any cars without the original engine block of

the model entered, and car with a transmission layout not as originally specified for that model, or a Specialist Rally Car without an engine complying with NCR Ch.14 App.4 Art.27.2. They need not be taxed.

**Note 4:**

The onus of responsibility for the eligibility of vehicles competing in the championship rests with the Entrant/Competitor. In the event of a dispute concerning the compliance of a vehicle to the regulations, the onus will be on the competitor to satisfy the organisers, NOT the organisers to prove compliance.

**Note 6:**

Tyre wrapping with single use plastic is not allowed during the events.

**20. All vehicles must comply with Motorsport UK National Competition Rules as appropriate. In particular notice should be taken of Chapter 14 of the NCR's.**

**Competitors' attention is specifically drawn to the requirements of NCR Ch.14 App.4 Art.1 which states: Road-Going Specialist Production, Modified Series Production Cars and Modified Specialist Production Cars must comply with NCR Ch.7 App.3 Art.20 and NCR Ch7. App.3 Art.21.**

**NCR Ch.14 App.4 Art.2.8 states: Sports Libre Cars and Racing Cars must be equipped with a homologated FIA safety harness complying with NCR Ch.7 App.7 Art.8 and NCR Ch.7 App.7 Art.9.**

**21. Awards will be presented as follows:**

**Saturday 26th April 2025**

- Fastest Time of Day -The Channon Trophy (to be held for one year) and Replica
- 1st in each Class - An Award
- 2nd in each Class - An Award (subject to 5 starters)
- 3rd in each Class - An Award (subject to 8 starters)
- Best Lady Driver - An Award (subject to 3 starters)

**Sunday 27th April 2025**

- Fastest Time of Day - The Mark Salter Memorial Trophy (to be held for one year) and Replica
- 1st in each Class - An Award
- 2nd in each Class - An Award (subject to 5 starters)
- 3rd in each Class - An Award (subject to 8 starters)
- Best Lady Driver - An Award (subject to 3 starters)
- Spirit of the Meeting - The Neville Heath Memorial Trophy
- Best Performance by a Woolbridge Member based on performance in class using the 2023 ASWMC class records – An Award

Additional awards may be added. No competitor may win more than one Award with the exception of the award for the Best Lady driver and Spirit of the Meeting.

**Entries**

22. The maximum entry for each Meeting is 130. The minimum for each event is 60 and 3 for each class. Should any of the minimum figures not be reached, the organisers have the right to amalgamate the classes. No car may be entered in more than one class and no driver may drive more than one car. A car may be shared by not more than two drivers.
23. The entry lists open upon publication of these regulations and **close on Monday 24<sup>th</sup> February 2025** due to a revamp of the Woolbridge MC website. The closing date could be extended subject to the amount of entries received, and please email [wiscombe@woolbridge.co.uk](mailto:wiscombe@woolbridge.co.uk) if you wish to enter after Monday 24<sup>th</sup> February.
- The entry fee is **£105.00 per event or £200.00 for both days.**  
Entries will only be accepted online and must be paid for at time of entering.
